4. The cost of any damage caused by the participant during one of the training sessions will be borne by participant or by the parent of such participant who shall pay for such damage in full.
5. All classes will be conducted in English.
6. STRYX treat the safety and well-being of all participants attending its courses as a priority. STRYX therefore reserves the right to remove any participant or parent/guardian who is repeatedly found bullying, misbehaving or generally being disruptive during the sessions / activities.
